Where you engaged in yard services for clients, you would be under the same rules.

Trust that I have a much better understanding of the laws in New York State than you ever will.

operating on behalf of Bullyville in pursuance of a class action lawsuit against a named Defendant Eric S. Chanson and Blue Mist Media,

He has infringed upon my trademark as well as the trademark of several other website owners who are interested in joining the class action lawsuit.


Of course, if you are, indeed a lawyer, I presume that you will have no difficulty refuting my post with some pretty simple information -- like your state of licensure.
